Terms and conditions.

1. The name of the project shall be "Gwadar Gymkhana" which consist of members in the club.
2. The Applicants are requested to make payment through crossed cheques or pay order in the name of company **GWADAR GYMKHANA** against receipts.
3. The application/process fee Rs.5000/=, which is non refundable.
4. The company shall open memberships of various type in the project, which are offered for sale on ownership basis.
5. The Clubs may issue membership cards to each Member, and at Member's discretion to a Spouse with Children (age up to 21 and un-married). Different family structure will be sent for review to the concern department and additional charges will be applied.
6. All Pakistanis and Non-Pakistanis living abroad are also eligible to apply.
7. All applications for booking allotments shall be submitted on the prescribed form/s dully filled in and signed by the applicant.
8. The commercial and residential plot/plots of the project shall be booked on the terms and conditions prescribed on application form, Cost and payment schedule specification undertaking and the approved documents shall be signed by applicant/member which will form part of the contract agreement.
9. The allocation of Membership shall remain provisional until the full payment is received by the company. Allocation of a particular number of Membership. The project is provisional and / or layout of Gwadar Gymkhana may be change or altered by the company on demand of local authorities.
10. The applicant within specific time shall make full payment of membership. If payment is not received by notified dates, the provisional allocation shall be cancelled and amount deposited by the applicant will be refunded after resale of the membership by the company and after deducting 25% of the total cost.
11. The applicant shall not sell, transfer, mortgage and /or assign the prior to taking over possession of the unit, subject to written consent of the company and payment of 5% of cost of membership by the application as transfer fee.
12. The applicant shall make the payment of membership within the period specified in the demand notice; otherwise a late payment charge will be levied at the prevailing bank rates for outstanding dues. If the applicant fails to pay the dues with late payment charges within the specified period in FINANCIAL NOTICE the allocation will be liable to be cancelled as per terms (8) of this form.
13. The member shall attend the companies and sub-registrar or any other officer department as and when needed and called upon by the company. Failure to attend the sub-registrar office on the intimated scheduled date by the member, an amount of Rs. 2000/- (Rupees two thousand) shall be charged as company's service charges. All the correspondence by the company including demand notice of payment, shall be posted at the last given address of the applicant, as per record of the company. The company shall, however, not be responsible for non delivery of demand notice and other correspondence due to any reason including change of address of the applicant, (communication where of has not been made to the company).
14. Although the company would make every effort to obtain electric, water supply, sewerage and gas supply at the earliest, yet the company accept no responsibility if the supply of any of the above mentioned services is delayed.
15. The member will pay all taxes etc, Levied federal/ provincial Government, Local bodies and Municipal bodies or any other authorities. Including these existing at present and those, which may be levied by the above mentioned and/or other authorities in future.
16. Charges for conservancy, water consumption for street lights and water pumps, charges for maintenance water supply, sewerage and other common amenities to Gwadar Gymkhana will be paid to the company until the formation of the society/ association of the residence/member.
17. Membership will nor be used for commercial purpose at all, at any time.
18. The Documentation charges for lease and other charges will be paid by the member as and when demanded by the company.
19. That if for any reason, the project is abandoned the company shall refund the amount received from the members within the earliest convenience of the company. 21. 5% special discount for handicapped/ disabled persons.
22. All terms and condition as updated from time to time by the managing committee Gwadar Gymkhana.
